Our Debit Card App Is Here! Download the "My Mobile Money Access" App Today!

Now you can protect your money by setting up custom alerts with My Mobile Money Access. The My Mobile Money Access app gives you control of your A & S Federal Credit Union debit card right from your smart phone. You'll be able to better manage and help protect your accounts from fraud with customizable alerts and service available 24/7.

With My Mobile Money Access, you can set interactive controls to help monitor activity and prevent unauthorized use. You can:

- Turn your card on or off.
- Set alerts based on merchant, amounts or transaction type and location.
- Monitor dependent cardholders' usage.
- Receive notification of possible fraudulent transactions and take action.

Important Information for ALL Members

Lost VISA or Debit Cards – Phone numbers to cancel a lost or stolen VISA or Debit Card can be accessed during non-business hours either by calling the office for the recorded after-hours message or on our website at asfederal.org. So don't wait if your card is lost or stolen. CALL IMMEDIATELY!

Cancel or Freezing Debit Cards Online – You can now cancel or "freeze" your Debit Card anytime 24/7 by logging into your online account. So even if you think you misplaced your card go online and "freeze" the card until you are sure. Freezes can be reversed at any time. Remember, this can be done with the "My Mobile Money Access" app on your phone.

Direct Deposit for Income Tax Refunds – The credit union's routing number for direct deposit is 243379475. If you are not sure of your correct account number, please call the credit union before you prepare your taxes.

Transaction-activated Statements – We want to remind our members that still receive their statements by mail and not electronically, that our statements are transaction activated. Other than at year-end, you will only receive a statement when there is activity on your account. Dividend posting is not considered activity.

Inactivity Fee - There will be a \$5.00 inactive fee quarterly on any account under \$10,000 that has not had any activity for three years. Dividend posting is not considered activity. To avoid any fee, keep your account active; make regular transactions to your account.

Traveling Notification - With all the fraud that is occurring, out of state transactions on your credit card may be denied.

Call the credit union before you travel to avoid any problems.

Verification of Accounts - We are conducting a verification of accounts. Please review your statement carefully. If you see any problems, contact Michael L. Smith, Chairman of the Supervisory Committee at 724-375-5940.

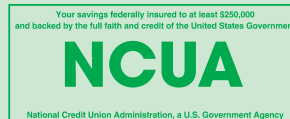
