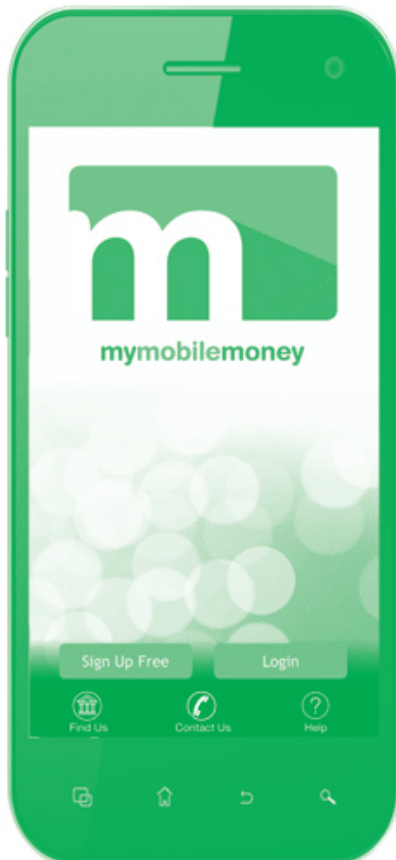
OUR DEBIT CARD APP IS HERE! Download the “My Mobile Money Access” app now!

Now you can protect your money by setting up custom alerts with My Mobile Money Access. The My Money Access app gives you control of your A & S Federal Credit Union debit card right from your smart phone. You'll be able to better manage and protect your accounts from fraud with customizable alerts and service available 24/7.

With My Mobile Money Access, you can set interactive controls to help monitor activity and prevent unauthorized use.

YOU CAN:

- Turn your card on or off
- Set alerts based on merchant, amounts or transaction type and location
- Monitor dependent cardholders' usage
- Receive notification of possible fraudulent transactions and take action

Protect Yourself Against Fraud

Fraud is an ever-growing problem. Be aware that our after hours message is on our phone system or on our website (asfederal.org). You can get the phone number to report



your debit card, ATM card or VISA credit card lost or stolen. These numbers have someone available 24/7 to stop your card. You can now stop your own debit card using our new My Money Mobile Access app.

Also, remember: NEVER give your personal information to anyone

unless it is initiated by you. If MasterCard or VISA call on behalf of the A & S Federal Credit Union to verify that a transaction is legitimate (which may happen from time to time) they will NOT ask for your information.

Protect your information! And if you feel there is a problem with your account in any way....don't wait....call immediately!

Traveling – Call Us Before You Leave!

With all the fraud that is occurring in today's world, many out of state (or country) credit or debit card transactions may be denied. Call us before you travel so we can indicate a travel notification on your behalf. Also, when you are outside Pennsylvania, a PIN based transaction for your debit card may be required for certain merchants.



So make sure when you are out of state you select "debit" transaction so that you may enter your PIN.

- Monday, October 9th - Columbus Day

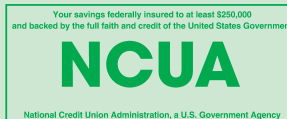
