A & S Federal Credit Union is required to notify our membership of the following change in terms to our Funds Availability Policy, which was due to statutory inflationary requirements. The following will become effective July 1, 2020:

1. \$225 next-day availability for all instances that were previously required to provide a minimum of \$200.
2. In addition, the \$5,000 availability requirements for holds on new accounts, large deposits, and repeat overdrafts will increase to \$5,525.
